AADR Call for Nominations: NIH Voluntary Reviewers

The AADR Board and Government Affairs Committee (GAC) are pleased to announce that the AADR will begin to regularly solicit the membership (twice per year) for qualified candidates to serve as NIH reviewers, and then coordinate with the NIH Council on Scientific Review (CSR) to submit those members' profiles to

the CSR Registry of Volunteer Reviewers. It is vitally important that more dental researchers serve as reviewers. NIH has reached out to scientific societies to provide CSR with more nominees to serve on Study Sections. As a result, we look forward to working with various Scientific Review Officers (SRO) and Initial Review Groups (IRG) to help the NIH identify the best dental researchers to serve as voluntary reviewers. The submissions will be vetted by the AADR Board and GAC before submission to CSR in order to ensure the highest quality reviewers.

NIH will use the registry as a key tool for Scientific Review Officers to (1) more quickly identify experienced, volunteer reviewers and (2) provide societies and institutions with additional input into the peer review process.

CSR is looking for potential reviewers who:

- Have substantial and broad independent research experience
- Have received major peer-reviewed grants either from NIH or an equivalent agency
- Understand the review process
- Are willing to consider serving for four years as study section members
