Department of Defense (DOD) Peer Reviewed Orthopaedic Research Program (PRORP). This  
program will support innovative, high-impact, clinically relevant research to advance treatment  
and rapid rehabilitation from musculoskeletal injuries sustained during military combat or  
combat-related activities.

Description: The PRORP Career Development Award is being offered for the first time in FY09. This award supports a mentored research experience to prepare military investigators without significant experience in orthopaedic research for a productive, independent career in this field. This award supports individuals in the early stages of their careers by providing the experience necessary to pursue career opportunities at the forefront of orthopaedic research and make significant contributions to combat-relevant orthopaedic research and/or clinical care. Pre-applications are REQUIRED for all PRORP award mechanisms.
